II. Registration – Interested candidates are required to register themselves and fill up the forms online in the State web portal www.statequota.sikkim.gov.in as per the schedule indicated below.

(i) For MBBS/ BDS/BASLP/BHMS/BAMS

- (a) Registration opens : 3rd September 2024 from 10:00 a.m.
(b) Registration closes : 10th September 2024 at 4:30 p.m.

Note : NEET mandatory.

(ii) For BVSc. &AH/ BSc. Agri./BSc. Horti./ BSc. Forestry/BSc. Food Nutrition and Dietetics/ BSc. Community Science/BSc. Fisheries/BSc. Natural Farming

- (a) Registration opens : 3rd September 2024 from 10:00 a.m.
(b) Registration closes : 10th September 2024 at 4:30 p.m.

Note : NEET appeared candidate are eligible for registration.

(iii) For B.Tech Agriculture Engineering / B.Tech Food Technology

- (a) Registration opens : 3rd September 2024 from 10:00 a.m.
(b) Registration closes : 10th September 2024 at 4:30 p.m.

Note : JEE (mains) appeared candidates are eligible for registration.

Please note that no extension of dates for online registration is permissible.

III. Registration fees – The registration fee of Rs. 450/- has to be paid online for registration. A provision for payment of registration fees through offline mode has also been facilitated by the State Bank of Sikkim. A candidate who desires to pay offline needs to visit the nearest State Bank of Sikkim.

3. *Residential Certificate or Trade License in the name of father or Parent's employment certificate in case of 'Others' community candidates.*
4. *Recent BPL certificate (issued by DESME), if any.*
5. *Date of Birth Certificate.*
6. *Class XII marksheet.*
7. ***Re-revised*** *scorecard of NEET-2024 for MBBS/ BDS/BASLP/BHMS/BAMS/BVSc. &AH/ BSc. Agri./BSc. Horti./ BSc. Forestry/BSc. Food Nutrition and Dietetics/ BSc. Community Science/BSc. Fisheries/Bsc. Natural Farming*
8. *JEE (Mains) scorecard for B.Tech Agriculture Engineering / B.Tech Food Technology*
9. *Persons with Benchmark Disability certificate, if any. Candidates applying under Persons with Benchmark Disability category for MBBS must fulfil the eligibility conditions for disability prescribed for appearing for NEET and as certified by the Social Welfare Department, Government of Sikkim.
